10	Brief Description of the Assignment	Techno Economic feasibility studies should be done to determine the projected profit and loss statement, cash-flow statement, break-even capacity, internal rate of return (IRR), Net Present Value (NPV), Benefit Cost Ratio (BCR), Economic Rate of Return (ERR) and sensitivity analysis. It will be necessary to conceptualize the PROJECT, review the capacity, product-mix and technology to be adopted for the PROJECT. Develop plant general layout, review the nature and sources of pollutants and to indicate necessary pollution mitigation measures, prepare an overall implementation schedule, estimate capital cost. Preparation of basic engineering drawing of a plant, develop general plant general layout drawing, prepare basic engineering drawing with cost estimation for all sheds, foundations, power distribution system and prepare basic schemes.
